Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated the week of March 16,2006, thru March 22, 2006, there was an average jail population of 149 prisoners. The highest number was 161 and the lowest 133. During the weekend of March 18-19, 2006, 84 prisoners were booked into the Cleveland County Detention Center. Of this number, 57 were released during the weekend and 21 were taken for arraignment on Monday, March 20, 2006. Three prisoners were taken to the Department of Correction. Three more should be eligible for transport to DOC within a few days, barring further legal delays. Mr. Vickers has continued discussions with Oklahoma Court Services to assist in implementing a new electronic monitoring service as an alternative to incarceration. He continues to look at the jail list daily and has brought to the attention of the Judges, of people being held on a rule 8. After review these people were released according to the conditions set by the Judges. Mr. Vickers will continue to monitor the jail list and make appropriate recommendations. As of today there were 146 inmates in the jail. George Skinner moved, seconded by Bill Graves, to approve.
