BOARD OF COUNTY COMMISSIONER'S

MINUTES

November 22, 2010

The regularly scheduled meeting of the Board of County Commissioners was called to order this 22nd day of November, 2010, in meeting room 200 of the Cleveland County Office Building by Chairman Rusty Sullivan. Tammy Howard, County Clerk/Secretary, called roll and those present were:

George Skinner moved, seconded by Rod Cleveland, to approve the minutes of the Regular Meeting of November 15, 2010.

Upon the request of Melinda Duke, Purchasing Agent, Rusty Sullivan moved, seconded by George Skinner, to accept the bids and to table the awarding and/or rejecting of County Bid #CT-1483 – The purchase of seven (7) Copiers for the County Treasurer's Office. The vote was: Rusty Sullivan, yes; George Skinner, yes; Rod Cleveland, yes. Motion Carried.

Jones, Norman, Oklahoma.

Chairman Sullivan paused the meeting for a moment to introduce to everyone the new Treasurer elect Jim Reynolds.

Chairman Sullivan called for under New Business the Discussion, Consideration, and/or Action regarding the 911 Fire Districts and Responding Fire Agencies, this item shall include an open discussion forum between the County, Five (5) Fire Chiefs and ACOG.

Rod Cleveland stated it was time to take a look at the unincorporated areas again and discuss which agency should be the primary responding agency to better serve the citizens of those areas. Mr. Cleveland stated the main discussion needs to be directed towards the northern part of the County but would like to discuss all areas of the County.

Dan Cary introduced Steve Eddy, ACCO 911 Director. Mr. Eddy stated the responding agencies for the unincorporated areas were agreed upon a little over 20 years ago and it is time to update this agreement.

Glenn Lewis, Mayor of the City of Moore, stated there were several options for everyone to look at, for example the cost issues for when an agency respond, create fire districts, or surrounding Cities annex in some of those areas.

The following Fire Chiefs spoke about what incorporated areas they were the primary responding agency for: Keith Bryant, City of Oklahoma City Fire Chief; Charles Stephens, City of Moore Fire Chief; James Fullingim, City of Norman Fire Chief, Gary Bonner, City of Noble Fire Chief, Allen Schneider, Little Axe Fire Chief, and the following were representatives: Marsha Blair, Town of Slaughterville, Jansen Idlett, Town of Lexington and Roger Wickey, Cedar Country Fire Department.

Rusty Sullivan moved, seconded by George Skinner, to approve the Contract between the Cleveland County Health Department and Vivian Y. Gibson for Directly Observed Therapy (DOT) and related services to tuberculosis (TB) patients at a rate of \$6.00 per visit and mileage in accordance with the State Travel Reimbursement Act (STRA) with is currently \$.50 per mile for a maximum reimbursement of \$5,915.00. Contract period will be from November 10, 2010 through June 30, 2011.

Rod Cleveland moved, seconded by George Skinner, to approve the Contract between the Cleveland County Health Department and Norman Regional Health System to provide chest X-rays for the purpose of diagnosis and control of Tuberculosis. Fees for the chest X-rays are based on the views ordered by the Health Department and range from \$67.00 to \$135.00 per view. Contract is from December 1, 2010 through November 30, 2011.
