Prices for ground transportation services provided by PTS are based on the direct mileage between pick-up and drop-off points. Mileage for moves within the nationwide network is determined by the computer program PC*MILER/STREETS.

Ground Transportation:

Rate for an adult male prisoner will be (\$0.95) per mile.

Rate for an adult female prisoner will be (\$0.95) per mile.

Minimum trip fee is (\$400.00).

Multiple Move Discount twenty five percent (25%).

Surcharges:

Special Needs such as juveniles, medical, short deadlines and release dates are priced on a case by case basis.

Same day/Court pick up. A transport when a prisoner is being picked up in a court will be priced on a case by case basis.

State / Federal Prison. A transport being done on a Form VI (Interstate Agreement on Detainers) out of a State of Federal Prison will be priced on a **case by case basis**.

End of Sentence / Release Dates. A transport when a prisoner is being released on a specific day will be priced on a **case by case basis.**

Limited Service Areas (LSA): PTS adheres to all DOT drive time regulations which restrict the distance we can travel in an allotted time frame. In some scenarios we will be able to service prisoners coming out of LSA's in our nationwide ground system. In most cases, due to DOT regulations prisoners will be best serviced by commercial air. The following states are outside our main servicing area and will be best serviced by air extraditions which are priced on a case by case basis. These states include Idaho, Montana, Nebraska, North Dakota, Oregon, South Dakota, Utah, Washington, and Wyoming.
