1 ½" S-4 (PG64-22) = 3,350 Tons

Tack coat to be applied prior to each lift of asphalt being placed for both Base Bid and Add Alternate.

Add Alternate (178<sup>th</sup> St. to 220<sup>th</sup> St.)

1" S-6 (PG64-22) leveling course 2,500 Tons

2" S-4 (PG64-22) Surfacing course 5,000 Tons

2 ½" S-3 (64-22) asphalt overlay (approx. 23' wide) on Calumet Rd. from Memorial Rd. north 3 miles to 178<sup>th</sup> St.

Immediately upon the S-3 placement surface course of 1 ½" S-4 (64-22) asphalt will be placed.

Add Alternate:

1" S-6 (PG64-22OK) asphalt leveling course (approx. 23' wide) on Calumet Rd. from 178<sup>th</sup> St. north 3 miles to 220<sup>th</sup> St. Immediately subsequent to the leveling course placement, 2" of S-4 (64-22OK) asphalt surfacing shall be placed.


