### Calumet Streets Project / District #3

Canadian County District #3 is seeking bids for Calumet Streets Project.

#### Specifications:

1 ½" Asphalt overlay for the following streets in Calumet, Oklahoma:

1. Freehome (from north side of park, north approximately 2,400 ft, excluding Todd St. to Main St.)
2. McKinley (from 122<sup>nd</sup> NW north to Main St., approximately 2,200 ft.)
3. Main St. (from U.S. 270 west to Garfield Ave., approximately 2,500 ft.)
4. W. 3<sup>rd</sup> St. (from U.S. 270 west to McKinley Ave., approximately 1,060 ft.)
5. Flynn Ave. (from 122<sup>nd</sup> St. NW to U.S. 270, approximately 3,050 ft.)

Details: The roadway widths vary from street to street. The first four streets will make up a Base Bid containing approximately 1,462 tons of S4 (PG70-28) hot mix asphalt. The fifth street will be bid as an Add Alternate and contains an estimated 655 tons of S4 (PG70-28) hot mix asphalt. All of the materials to be hauled, placed (FOB jobsite) and compacted as per Oklahoma Department of Transportation (ODOT) specifications, current edition. Tact coat is to be placed incidental to the asphalt bid.

All material to comply with ODOT specifications, current edition.

Smooth transition shall be obtained in all directions at intersections.

Contractor shall be responsible for all Traffic Control.

The awarded vendor will be presented a written contract to be executed and returned to Canadian County within 7 calendar days from the date of Award.

All work on the project to be complete by October 26, 2018. Liquidated damages of \$500 per calendar day will apply after date.

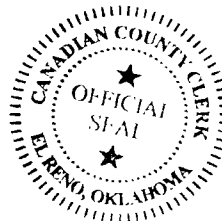
