The Canadian County EXPO & Event Center is a multi-use facility that ranges from equestrian to tradeshow use throughout the year. We are requesting bids for carpet that will be used to cover the dirt floor of our indoor arena during trade shows.

Please include in your bid:

Option 1: Carpet must be available no later than January 17, 2022.

- Different grades of carpet (example: medium duty, heavy duty etc.)
- Color options (we prefer gray or dark blue) Carpet will have heavy foot traffic, spills, dirt etc.
