• Piedmont Public Schools

Upon roll call: Hodges, yes; Jantz, yes; Ramsey, yes. The motion passed 3-0.

There was no new business.

At 10:27am, Hodges declared a recess until 10:30am.

At 10:34am, Hodges reconvened the meeting.

The Excise Board, County Commissioners, County Officers and Department Heads discussed the FY2019 General Fund Budget.

The proposed revisions to the estimates of needs as follows:

- \$32 per month increase to the benefit allowance beginning January. (Unless you opt out) This will help to offset any increases to the employee's health insurance premiums.
- 4% increase to each office's budget to be distributed at the discretion of the officer.
- \$100 per month increase to the family coverage for the benefit allowance tier structure.
- Chief Deputy's salaries brought up to 85% of the amount the officers will be making.

The revisions to the estimates of need from the June 28, 2018 meeting and the proposed revisions presented today resulted in a balanced total budget of \$25,349,904.00.

Jantz moved, seconded by Hodges to authorize the County Clerk to forward the balanced estimates of need budget for FY2019 to the budget maker. The FY2019 General Fund budget will be formally approved in September.
