Under new business:

Commissioner Anderson provided information to the Board on the Canadian County Children's Justice Center's FY2020 Budget.

At 10:27am, Ramsey declared a recess until 10:30am.

At 10:35am, Ramsey reconvened the meeting.

The Excise Board, County Commissioners, County Officers and Department Heads discussed the FY2020 General Fund Budget.

Commissioner Chairman David Anderson presented additional proposed revisions to the estimates of need as follows:

- \$30 per month increase to the benefit allowance beginning January. (Unless you opt out). This will help offset any increases to the employee's health insurance premiums.
- 3% merit increase to each office's budget to be distributed at the discretion of the officer.
- \$100 per month increase to the family overage for the benefit allowance tier structure.
- \$50 increase to the Deferred Compensation 457B Employer Match Plan.
- Increase the Election Board Secretary's salary to the next scheduled state level of \$61,645.00. The County will increase the salary as a supplement only until the time it is increased to that level by the state.
- Increased the Capital Improvements Projects account by \$386,359.00.
- Achieved a 10% (Capital Outlay) Reserves.

The revisions to the estimates of need from the June 25, 2019 meeting and the proposed revisions presented today resulted in a balanced total budget of \$31,092,397.00.

Ramsey moved, seconded by Harrison to direct the County Clerk to forward the balanced estimate of need budget for FY2020 to the budget maker. The FY2020 General Fund budget will be formally approved on September 24, 2019. Upon roll call: Ramsey, yes; Mengers, yes; Harrison, yes. The motion passed 3-0.

Ramsey moved, seconded by Harrison to adjourn. Upon roll call: Ramsey, yes; Mengers, yes; Harrison, yes. The motion passed 3-0. The meeting was adjourned at 10:38am.
