The Excise Board, County Commissioners, County Officers and Department Heads discussed the FY2021 General Fund Budget. The estimate of revenue is \$31,984,705.00. The updated budget surplus to be balanced is \$1,346,705.00 which includes the following:

- \$50.00 per month increase to the county deferred comp 401a, for a total of \$150.00 per month.
- \$15.00 per month increase to the benefit allowance beginning January. Previous amount was \$735.00, new amount will be \$750.00. (Unless you opt out). This will help to offset any increases to the employee's health insurance premiums.
- \$100.00 per month increase to the family coverage for the benefit allowance tier structure.

- Pay off the balance of the Jail Construction Loan payment in the amount of \$1,706,362.81.
- \$104,000.00 increase for the Property/Liability deductible fund reimbursement account which will be identified by the respected office.
- 3% merit raise increase to each officer's budget to be distributed at the discretion of the officer.
- Balance of uncommitted funds to be placed in the Capital Improvement Projects line item under General Government.

Commissioner David Anderson presented an additional proposed revision to the estimates of need as follows:

• \$94,195.00 to be added to the General Fund Estimate of Needs to help fund the Family Justice Center Project.

The revisions to the estimates of need from the August 25, 2020 meeting and the proposed revisions presented today resulted in a balanced total budget of \$31,984,705.00.

The BOCC directed the County Clerk to forward the balanced estimate of need budget for FY2021 to the budget maker.

There was no new business.
