The Board considered approval of the permit application for DCP Midstream, L.P. to bury a natural gas pipeline in the NE/4 Section 12 and the SE/4 Section 1 of T13N R9W and install a natural gas meter run in the SE/4 Section 1 T13N R9W (District 3). Austin moved to approve with a flood protection fence for the meter run; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit 037-010

The Board considered approval of the permit application for Devon Gas Services, L.P. to bury a natural gas pipeline in Section 35 of T14N R9W and Section 2 of T13N R9W, and install an above ground valve in Section 35 T14N R9W (District 3). Richey moved to approve with a flood protection fence around the valve; Austin seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit 038-010

The Board considered approval of the permit application for Devon Gas Services, L.P. to bury a natural gas pipeline in the SW/4 Section 23 and the SW/4 Section 24 of T12N R10W (District 3). Austin moved to approve; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit 039-010

The Board considered approval of the permit application for ONEOK Field Services Company, L.L.C. to bury a natural gas pipeline in Section 35 T14N R10W (District 3).

The Board considered approval of the permit application for ONEOK Field Services Company, L.L.C. to bury a natural gas pipeline and install a natural gas meter run in the NE/4 Section 5 of T11N R9W (District 3).
