The Board considered approval of the permit application for Cimarex Energy Company to drill an oil/gas well and store production equipment in the NE/4 Section 16 T14N R10W, Adamson 1-9H, District 3. Austin moved to approve the permit with anchoring of all equipment and a well head protection fence; Richey seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit #003-011.

The Board considered approval of the permit application for Cimarex Energy Company to drill an oil/gas well and store production equipment in the SW/4 Section 10 T13N R8W, Sandburr 1-10H, District 1. Austin moved to approve the permit with double anchoring of the tank battery, anchoring of all other equipment, and a well head protection fence; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit #004-011.

The Board considered approval of the permit application for ONEOK Field Services Co. LLC to bury a natural gas pipeline in SE/4 Section 20 T13N R9W, District 3. Richey moved to approve the permit; Austin seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Permit #005-011.

The Board considered approval of the permit application for ONEOK Field Services Co. LLC to bury a natural gas pipeline in S/2 Section 35 T14N R10W, District 3. Austin moved
