Bearden called the meeting to order at 1:38 p.m. and announced that a quorum was present.

McLoud moved to accept the minutes of the May 2, 2011 Regular Meeting; Richey seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Motion passed.

There were no comments from the public.

The Board considered approval of the permit application for Cimarex Energy Company to drill an oil/gas well and store production equipment in the NW/4 Section 29 T13N R8W, Clark 1-20H, District 3. Austin moved to approve with anchoring of production equipment but not flood fence; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Motion passed. Permit #026-011.

The Board considered approval of the permit application for Cimarex Energy Company to drill an oil/gas well and store production equipment in the SE/4 Section 32 T11N R9W, Double H 1-32H, District 2. Richey moved to approve with anchoring of production equipment and a flood protection fence at the well head; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Motion passed. Permit #027-011.

The Board considered approval of the permit application for Devon Gas Services L.P. to bury a natural gas pipeline and install a valve in the SW/4 Section 4 T11N R8W, District 2. Richey moved to approve with a flood protection fence at the valve; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Motion passed. Permit #035-011.

The Board considered approval of the permit application for Jeannette Burgess to replace her mobile home at 508 Britton Rd NE provided that the bottom of the new mobile home I-beam is 2 feet above the Base Flood Elevation. Mrs. Burgess' home was destroyed in the May 24, 2011 tornado.

Under New Business Austin moved to waive floodplain permit fees for the May 24, 2011 Tornado victims; McLoud seconded. Voting aye: Austin, Bearden, McLoud, and Richey. Motion passed.
