Canadian County Public Facilities Authority Board of Trustees Special Meeting June 27, 2011

The Canadian County Public Facilities Authority Board of Trustees met at 10:30 am in the Public Meeting Room, Canadian County Courthouse, 201 N. Choctaw, El Reno, Oklahoma. Those present were Trustee Chairman Phil Carson, Trustee David Anderson and Trustee Jack Stewart. Others present were Recording Secretary Jennifer Ramey, Bridge Engineer CC Shah, Authority Counsel Matt VonTungeln, County Clerk Shelley Dickerson, Sheriff Randy Edwards, Judge Bob Hughey, Tribune representative Traci Chapman, and Canadian County Juvenile Justice Center Facility Director Joan South.

Notice of the meeting had been posted as required by law.

Carson called the meeting to order

Discussion was made to consider for approval the FY2012 Budget for Children's Justice Center presented by Joan South and Judge Hughey. After review and discussion of the presented budget, motion was made by Anderson to deduct \$80,000 from the presented sales tax transfer amount of \$4,991,033.32 to \$4,911,033.32 for a total budget amount of \$7,261,282.32. This motion was seconded by Stewart. Upon roll call: Carson, No; Stewart, Yes; Anderson, Yes. The motion carried 2-1.

Discussion was made to review the monthly transfer resolution from PFA to CCJJC. Motion was made by Anderson to approve a monthly transfer of \$409,252.78 per month to the CCJJC. This motion was seconded by Stewart. Upon roll call: Carson, No; Stewart, Yes; Anderson, Yes. The motion carried 2-1.

Motion was made by Stewart and seconded by Anderson to approve the current agreement, pending possible modification in relation to Central Oklahoma Workforce Investment Board, with the Board of County Commissioners of Canadian County Office Building, for property at 210 North Choctaw, El Reno, Oklahoma for FY 2011-2012. Discussion was made to enter into an agreement with Central Oklahoma Workforce Investment Board to occupy the building located at 210 N Choctaw for the purpose of expanding the services provided to adults and dislocated workers in Canadian County. Anderson and Eddie Foreman will get together with Bass Law Firm to discuss the lease agreement and details.
