Building measurements: 70' x 225' with 18' height middle to 16' front on each side. Bays to be 25' wide and 35' deep both sides.

100' partition wall between sides with remaining 100' open for drive through purposes.

Concrete piers under each column—30 piers

10' x 10' insulated power washer room sheeted on all sides with concrete floor in bay next to the wash bay with 5' door (slide or double)

25' x 35' concrete floor wash bay 6" thick with ½" rebar on 2" centers added to end of the lean-to

Installation of Concrete mud, sand, and water separator in floor of wash bay. Ready to be plumbed by customer.

Customer will supply all I-beams needed for legs and rafters.

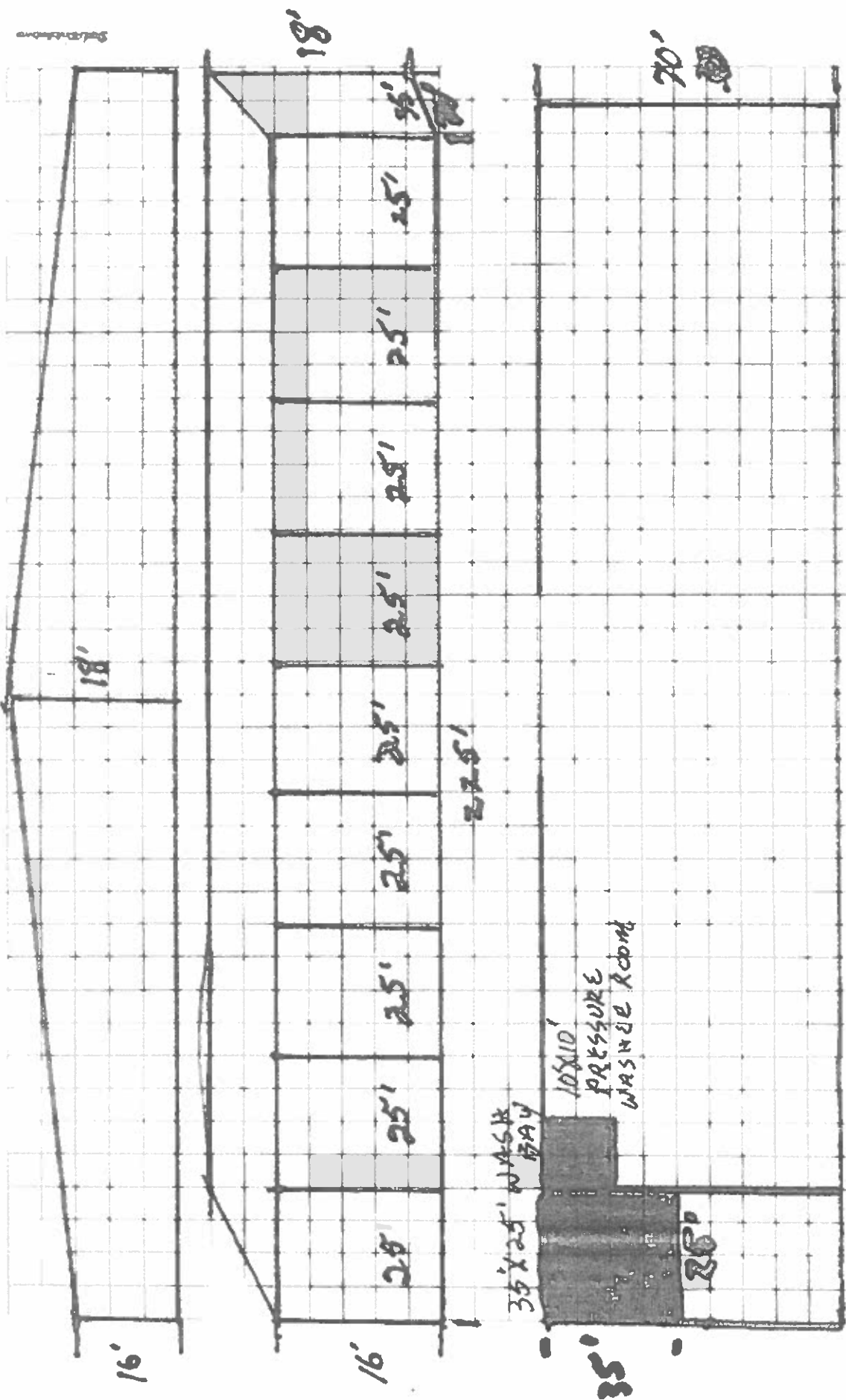
Materials to include: concrete for piers, perlins and sheet metal for roof, ends of building and 100' center and wash room.
