The regularly scheduled meeting of the Cleveland County Budget Board was called to order this 22nd day of April, 2002, in the conference room of the County Office Building by Chairman George Skinner. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

After the reading of the minutes of the regular meeting of April 8, 2002, and there being no additions or corrections Denise Heaver moved that the minutes be approved. Bill Graves seconded the motion.

- b. From Purchasing's, Personal Services, SP1A, \$4,000.00, and Purchasing's, Maintenance and Operation, SP2, \$4,000.00, to Purchasing's Capital Outlay, SP3, \$8,000.00.
- c. From Assessor's Personal Services, H1A, \$25,000.00, and Assessor's Travel, H1C, \$13,000.00, to Assessor's Maintenance & Operation, H2, \$38,000.00.

There is a House Bill that is being supported by County Officials and it is #2853.
