After the reading of the minutes of the regular meeting of February 23, 2004, and there being no additions or corrections, Rhonda Hall moved that the minutes be approved. F. DeWayne Beggs seconded the motion.

- a. From Commissioners Travel, D1C, \$5,000.00 and Commissioners Maintenance & Operations, D2, \$11,000.00, to Commissioners Personal Services, D1A, \$16,000.00.
- b. From Election Board Personal Services, Full Time, SL1A, \$15,500.00, to Election Board Personal Services, Part Time, SL1B, \$14,000.00, Election Board Travel, \$1,200.00 and Election Board Capital Outlay, SL3, \$300.00.
- c. From Sheriff's Service Fee Fund, Maintenance and Operations, CFB2, \$85,000.00, to Sheriff's Service Fee Fund, Personal Services, CFB1A.
- d. From Sheriff's Revolving Fund Personal Services, CFBRE1A, \$15,000.00, to Sheriff's Revolving Fund Maintenance & Operations, CFBRE2.
