George Skinner moved, seconded by Saundra DeSelms, to approve the following Transfer of Appropriations:

- a. From County Clerk's Maintenance & Operations, F2A, \$16,000.00, to County Clerk's Personal Services Full Time, F1A.
- b. From General Government Maintenance & Operations, R2, \$8,000.00, to Election Board Personal Services, Full Time, SL1A.
- c. From Highway General Maintenance & Operations, SA2, \$58,363.77, to Highway General Capital Outlay, SA3. (District #1)
- d. From Highway General Maintenance & Operations, SA2, \$64,237.08, to Highway General Capital Outlay, SA3. (District #2)
- e. From Juvenile Capital Outlay, SA3, \$1,439.30, to Juvenile Maintenance & Operations, SA2.
- f. From OSU Extension: Personal Services, E1A, \$2,000.00; Travel, E1C, \$2,000.00; and Maintenance & Operations, E2, \$2,000.00, to OSU Extension Capital Outlay, E3, \$6,000.00.

The Board discussed the bill that was before the Governor to sign on County's offering longevity pay, where the bill says may participate and not shall participate. Dorinda Harvey, County Clerk, stated that all budgets would have to be redone as no one planned for it.
