

November 8, 2004

The regularly scheduled meeting of the Cleveland County Budget Board was called to order this 8th day of November, 2004, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Bill Graves. Roll was called by Kerrie Hudson, Chief Deputy County Clerk/Secretary and those present were:

After the reading of the minutes of the regular meeting of October 25, 2004, and there being no additions or corrections, George Skinner moved that the minutes be approved. Denise Heavner seconded the motion.

Rhonda Hall moved, seconded by Denise Heavner, to approve the following Transfer of Appropriations:

Dan Cary stated he would come up with something reserving them without saying whom they are for.

Rhonda Hall suggested moving them to the center so they are not up against the building, and people would not think that they were for abstract customers.

Denise Heavner suggested putting reserved for a certain number.
