- c. From Sheriff's Travel, B1C, \$2,000.00 and Sheriff's Capital Outlay, B3, \$199,500.00, to Sheriff's Personal Services Full Time, B1A \$ 195,000.00 and Sheriff's Personal Services Part Time, B1B \$6,500.00.
- d. From Sheriff's Service Fee Maintenance & Operations CFB2, \$2,500.00, to Sheriff's Service Fee Personal Services, CFB1A.
