

November 27, 2006

The regularly scheduled meeting of the Cleveland County Budget Board was called to order this 27<sup>th</sup> day of November, 2006, in the conference room of the Cleveland County Office Building, by Chairman Leroy Krohmer. Member F. DeWayne Beggs entered the meeting during the roll call to approve the minutes.

After the reading of the minutes of the regular meeting of November 13, 2006, and there being no additions or corrections, Rhonda Hall moved that the minutes be approved.

Saundra DeSelms seconded the motion.

- b. From Sheriff's Lease/Purchase, B5, \$5,000.00, to Sheriff's Capital Outlay, B3.

Sandra DeSelms brought up the fact that when people smoke on the west side of the building, that smoke comes into her office through the windows.

Leroy Krohmer stated we would get some static from the Judges because they have wanted the Commissioners to make a smoke room for them outside.

Different Board Members spoke about where people are now smoking and a place being designated as a smoking area. The Board also discussed whether the law stated twenty-five (25) feet from a door or twenty-five (25) feet away from the building.

This would be a Commissioners decision as they are in charge of the buildings.

Christmas Dinner was discussed and this year it will be December 11, and the County Assessor's Office will host it.

There being no further business to come before the Board, Dorinda Harvey moved that the meeting be adjourned. F. DeWayne Beggs seconded the motion.
