Mr. Sullivan asked, where are we at on putting some pressure on this construction company to get this remodeling project done? Mr. Sullivan is very concerned about this situation and he has even witnessed only seeing one or two construction workers working on this project at one time.

Chairman Skinner stated he would get with Bob Wood and Mike Kelly to try and get this restroom situation resolved.

Vickie Wilson, Cleveland County's Budget Maker, entered the meeting at this time.

Chairman Skinner called for the Public Hearing on Cleveland County's Fiscal Year 2007/2008 Budget.

Vickie Wilson, Cleveland County's Budget Maker, gave a copy of the budget to all Board Members, and stated this was just finalizing what the Board has already approved, which was last years budget approved last September and we are here to have the public hearing to see if anyone from the public had an input. Vickie Wilson also stated Cleveland County has a balanced budget.
