

# Minutes

January 28, 2008

The regular meeting of the Cleveland County Budget Board was called to order this 28th of January, 2008, in the conference room of the Cleveland County Office Building by Vice-Chairman Denise Heavner. Tammy Howard, County Clerk/Secretary, called roll and those present were:

Vice-Chairman Heavner called for miscellaneous discussion.

Saundra DeSelms asked since the evacuation plan is currently not in place yet, can the next time the County has a bomb threat could the Offices tell the employees to come back in 1-1/2 hours?

Vice-Chairman Heavner stated that has been the time frame for the last few bomb threats.

Saundra DeSelms stated it would work out better for the employees, instead of having them stand outside in the cold weather.

Rusty Sullivan stated that was a good idea till the County can approve and implement an evacuation plan.

David Batton, A.D.A., stated he was currently working the evacuation plan with Dan Cary and Lt. David Mobley. They are working on finalizing the plan to present it to the Budget Board for any additions or changes before presenting the plan to the Board of County Commissioners.

There being no further business to come before the Board, Sandra DeSelms moved that the meeting be adjourned. Vice-Chairman Heavner seconded the motion.
