- b. From Sheriff's, Capital Outlay Law Enforcement, B3-200, \$30,000.00 to Maintenance & Operations Administrative, B2A-100, \$17,000.00, Capital Outlay Administrative, B3-100, \$12,000.00, and Capital Outlay Support, B3-500, \$1000.00.
- c. From Sheriff's, Personal Services PT Support, B1B-500, \$5,000.00 to Personal Services PT Law Enforcement, B1B-200, \$2,500.00 and Personal Services PT Detention, B1B-300, \$2,500.00.
- d. From Sheriff's Revolving Fund, Maintenance & Operations Administrative, CFBRE2-100, \$25,000.00 to Personal Services Law Enforcement, CFBRE1A-200.
- e. From General Government, Maintenance & Operations, R2, \$13,682.00 to Sheriff's Department, Board of Prisoners, B2B-300
