- b. From General Government, Maintenance & Operations, R2, \$11,860.00 to Sheriff's Department, Board of Prisoners, B2B.
- c. From Election Board General Government, Personal Services Full-time, SL1A, \$2,964.56, Personal Services Part-time, SL1B, \$3,938.10 and Capital Outlay, SL3, \$8,132.88 to Election Board General Government, Maintenance & Operations, SL2, \$11,955.54.
