- c. From Sheriff's Department, Personal Services, B1A, \$11,550.00; Travel, B1C, \$922.06 and Maintenance & Operations, B2A, \$4,881.28 to Sheriff's Department, Capital Outlay, B3, \$17,353.34.
- d. From the Fair Board, Personal Services, SF1A, \$6,454.66; Personal Services Part-time, SF1B, \$6,340.77; Travel, SF1C, \$200.00 and Maintenance & Operations, SF2, \$7,121.00 to Capital Outlay, SF3, \$20,116.43.
