Rod Cleveland moved, seconded by David Tinsley, to approve the minutes of the regular meeting of July 26, 2010.

Member Joe Lester entered the meeting at 9:37 a.m.

Chairman Sullivan called for the Presentation by Representatives from Healthchoice regarding the County's Insurance Policy.

David Rose, Member Services, was the first presenter from Heathchoice. Mr. Rose gave an overview as follows:

HealthChoice is self-insured

2011 there will be no lifetime maximum on drugs

No limitations on calendar or lifetime benefits

HealthChoice has a four (4) tear rate structure: member, spouse, child and children Looking at reducing \$50.00 copay for next year plan. Could drop to \$35 or \$40.

Have a tear structure on drugs, with maximum co-pay structure

Mr. Rose stated when looking at other providers, look at:

Their re-issuance contract, which is an additional cost-plus billed exta.

Trust Plan Agreement to give rate and utilization, which sets surcharge and can increase if utilization increases

Trust plan pays into high-risk pool which equal percentage of premiums

A lot of insurance companies will not cover mental issues

Look at administrative costs

Chairman Sullivan asked about doctors getting paid for claims.

Mr. Rose explained that H.P. didn't have their computer system set up on a percentage bases. It took several months to correct.

Tricia Parker, Member Services Retiree Unit, presented on Retirees, Pre-Medicare and Medicare benefits.

If county leaves the state coverage, they must take the retires

If county wants to come back, the retires must be enrolled in a group plan to be eligible to return

Cleveland County has 20 members that are pre-Medicare, 3 to 4 with spouses and 55 Members Medicare eligible with 9 spouses

There being no further business to come before the Board, Tammy Howard moved that the meeting be adjourned. George Skinner seconded the motion.
