**MINUTES**  
**June 25, 2012**  
**SPECIAL MEETING**

The special meeting of the Cleveland County Budget Board was called to order at 10:18 a.m. this 25<sup>th</sup> day of June, 2012 in meeting room 240 of the Cleveland County Office Building by Rod Cleveland. Tammy Howard, County Clerk/Secretary, called roll and those present were:

- a. From Treasurer Personal Services, C1A, \$6,110.10 and Treasurer Travel, C1C, to Treasurer Capital Outlay, C3, \$1,000.00 and Treasurer Maintenance and Operations, C2 \$8,712.15.
- b. From Election Board Personal Services Full Time, SL1A, \$749.16, and Personal Services Part Time, SL1B, \$151.93 to Election Board Maintenance and Operations, SL2, \$901.09.
- c. From Sheriff, Cleveland County Justice Center Travel, CCJC1C, \$28,352.68 and Sheriff, Cleveland County Justice Center M & O, CCJC2, \$7,000.00 to Sheriff, Cleveland County Justice Center Capital Outlay, CCJC3, \$35,352.68.
- d. From Sheriff, Personal Services, B1A, \$67,377.24 and Maintenance & Operations, B2A, \$15,644.38 to Sheriff, Capital Outlay, \$83,021.62.
