SEPTEMBER 14, 2015

After the reading of the minutes of the regular meeting of August 10, 2015 and there being no additions or corrections, David Tinsley moved that the minutes be **approved**. Darry Stacy seconded the motion.

A. Old Business:

1. After the reading of the minutes of the Regular meeting of July 13, 2015; Special Meeting of July 20, 2015; and Special Meeting of August 03, 2015, and there being no additions or corrections, Harold Haralson moved that the minutes be approved. David Tinsley seconded the motion.

B. Items of Business:

1. Discussion was had on the EAP Project and a study of the Employee Assistance Program overview of services submitted by Wiley D. Harwell, D. Min., LPC.

Harold Haralson moved that the proposal be approved for three sessions per incident until the end of the fiscal year for trial basis to see how it goes pending more information.

Chairman Cleveland said that there is no Wellness Counseling Contract yet or money in the budget allocated for it. Further, the general consensus was to do more study of the EAP terms for consideration at a later date.

- 2. Shelley Taylor updated the Board on the HR Department; she announced the Health Fair scheduled for September 17, 2015 is throughout the County Office Building and that the same goes for the Group Health Insurance Seminar scheduled for Thursday, October 1st, 2015 and discussed the following:
 - **a.** 2016 Healthcare Premiums. (A copy attached hereto and made part of these minutes.)

- **C**. No **new business** was presented to the Board for discussion.
- D. Discussion was had by the Board Members about County Business, as follows: County Assessor David Tinsley said that the preliminary will increase by \$600,000.00 to public service because the State Ad Valorem Division missed ten companies. Tammy Belinson said that until they receive the final numbers it may delay the county budget. It is a matter of getting everyone's budgets in and may have to call a Special Excise Board Meeting on October 1, 2015.
