#### 9:00 A.M.

The special scheduled meeting of the Cleveland County Budget Board was called to order at 9:00 a.m. this  $16^{th}$  day of May 2016 in the conference room of the Cleveland County Office Building by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

## A. Items of Business:

- 1. Darry Stacy moved, seconded by David Tinsley, to approve the **Transfer of Appropriations regarding the following:** 
  - **a.** From **Co. Commissioner**, CFLEPC3, Local Emergency Planning Capital Outlay, \$5,000.00 to **Co. Commissioner**, CFLEPC2, Local Emergency Planning M & O, \$5,000.00.

He said that the Excise Board has to accept the Estimate of Needs and will set up a special Budget Board on Thursday, May 19, 2016, at 1:30 p.m. to approve the budget before the Excise Board meets on May 26, 2016.
