### **MINUTES**

#### **JUNE 13, 2016**

The regularly scheduled meeting of the Cleveland County Budget Board was called to order at 10:30 a.m. this 13th day of June 2016 in the conference room at 122 E. Eufaula Street by Chairman Rod Cleveland. Tammy Belinson, County Clerk/Secretary, called roll and those present were:

Darry Stacy and Sheriff Joseph Lester, Members, were absent.

Others present were: Assistant District Attorney Jim Robertson, Assistant District Attorney Heather Darby, Linda Atkins, Christine Cartmell, Melinda Duke, Bryan Jenkins, Brenda Hill, Teri Cox, Jacob McHughes, Annette Pretty and Christie Morren.

After the reading of the minutes of the Regular meeting of May 9, 2016; Special Meeting of May 16, 2016 and Special Meeting of May 19, 2016 and there being no additions or corrections, Harold Haralson moved that the minutes be **approved**. Rhonda Hall seconded the motion.

Motion carried.

#### A. Items of Business:

- Chairman Cleveland called for Public Hearing on Cleveland County's Fiscal Year 2016/2017 Budget. There being no public present to express opinions or concerns the hearing was closed.
- 2. Harold Haralson moved to adopt the Cleveland County's FY 2016/2017 Budget with the provision that when the final budget comes in that any excess money be placed in the Capital Outlay Account. Tammy Belinson seconded the motion. The vote was: Rod Cleveland, yes; Jim Reynolds, yes; Tammy Belinson, yes; Rhonda Hall, yes; Harold Haralson, yes; David Tinsley, yes. Motion carried.
- 3. Harold Haralson moved to adopt the Committee on Insurance's recommendation to the Board of Cleveland County Commissioners to hire Gallagher Benefit Services as an employee benefits consultant in the amount of \$65,000.00 per year for their service.

Tammy Belinson seconded the motion.

- 4. Teri Cox updated on the **HR Department** by saying that they are implementing drug testing for new hires and are trying to do all of the applications on line in an attempt to make everything electrically as possible.
- 5. Melinda Duke reported that the **Purchasing Department** went out for bid on the standing desks and the award went to Varidesk for a three month bid period which will expire August 31, 2016. She asked that orders be turned in before the deadline.
- 6. Chairman Cleveland called for discussion and/or action on the Requested Transfer of Appropriations regarding the following:

- **d.** From **Assessor**, **HR1C**, Assessor Reval Travel, \$8,000.00 to **Assessor**, HR2, Assessor Reval M & O, \$8,000.00; and
- e. From Assessor, H1A, Assessor Payroll, \$3,000.00 to Assessor, H3, Assessor Capital Outlay, \$3,000.00.

The vote was: Rod Cleveland, yes; Jim Reynolds, yes; Tammy Belinson, yes; Rhonda Hall, yes; Harold Haralson, yes; David Tinsley, yes. Motion carried.

Rhonda Hall moved, seconded by David Tinsley, to **approve** the Transfer of Appropriations as follows:

- i. From Sheriff, R3BS1A, Building Security Personal Services, \$77,000.00; R3BS1C, Building Security Travel, \$90.00; and R3BS2A, Building Security Materials & Operations, \$1,751.42 to Sheriff, R3BS3A, Building Security Capital Outlay, \$78,841.42.
