 - d. From **Sheriff, R3BS1A**, Building Security Personal Services, \$3,986.29; **R3BS2A**, Building Security Materials & Operations, \$204.99 to **Sheriff, R3BS3A**, Building Security Capital Outlay, \$4,191.28.

Motion carried.


B. No Board Members discussion was had about **County Business**.

Motion carried.


