SEPTEMBER 12, 2016

A. Items of Business:

Chairman Haralson called for discussion on **Item 5** as follows: **Presentation by United Way of Norman, Von Allen,** President/CEO and Pictures taken with Officials.

During the presentation made by Von Allen, President/CEO of the United Way of Norman, he said that 99 % of the support given stays in Cleveland County. The Budget Board members heard from J. D. Younger and Linda Price as well. Rod Cleveland suggested they do a challenge to get the momentum going for a goal of 100% participation.

1. Chairman Haralson updated on Health Insurance from the Insurance Review Committee. The Committee met last week with Gallagher Benefit Services to listen to a presentation. The committee has opted to move down the pathway toward self-insurance, but they haven't made any irreversible steps at this point. The committee is waiting to get a date together for the RFPs, consisting of three companies, to come and present to the Budget Board what they expect the program will look like.

- 2. Teri Cox updated on the HR Department. Ms. Cox discussed working on RFPs and Health Insurance. She is continually updating the contact distribution list and gathering employee data. The Health Fair is September 28, 2016 from 10:00 am to 3:00 pm. There are thirty providers so far with about five more committing to the Health Fair next week.
- 3. Melinda Duke **updated** on the **Purchasing Department** to let the Board know that she will be out of the office tomorrow morning (September 13, 2016) until about 12:00 noon for a P-card training class here in Norman. She will leave the door open for those dropping off Requisitions.
- 4. Sheriff Joseph Lester moved, seconded by Rod Cleveland, to **approve** the **Requested Transfer of Appropriations regarding the following:**
 - a. From **Sheriff**, **B2A**, Materials & Operation, \$6,500.00 to **Sheriff**, **B1C**, Travel, \$6,500.00.
