A. Items of Business:

1. Requested Transfer of Appropriations:

(Per O.S. Title 68, Chapter 1, Art. 30, Sect. 3021 & O.S. Title 62, Chapter 2, Sect. 461)

Sheriff Lester moved, seconded by David Tinsley, to **approve** the following Transfer of Appropriations as requested by Sheriff Joseph Lester, Cleveland County Sheriff's Office:

- a. Transfer within the Sheriff's Building Security Account, Maintenance & Operations - R3BS2A, \$688.00 to Capital Outlay - R3BS3A.
- b. Transfer within the Sheriff's Cleveland County Justice Center Account, Travel - CCJC1C, \$2,276.47 to Maintenance & Operations - CCJC2.
- c. Transfer with the Sheriff's Administration & Operations Account, Travel - B1C, \$738.00 to Maintenance & Operations - B2A.



Motion carried.




