Chairman Skinner called for Item # 1, discussion, consideration, and/or action to approve the Special Encumbrance Agreement and Resolution for the Building Renovation and Remodel of Courtrooms, Judicial Spaces, and Associated Space for the provision of Judicial Services in the Cleveland County Courthouse and the Cleveland County Office Building in the amount of \$2,404,861.40. Chairman Skinner asked for Judge Hetherington to explain. He said, that after receiving the encumbrance order this should put us in a position to start encumbering funds next quarter encumbrance period. He stated, as he has said several times that there is still no guarantee by anybody that the Chief Justice will sign this encumbrance order. By receiving this order it is good news that we may start receiving some encumbrance request. He stated, that the project should move forward and with the Resolutions we are headed in the right direction. Dewayne Rhodes stated, he had all signatures by everyone except the Judges, but they have signed off we just don't have formal signatures. Judge Hetherington asked, as required in the document that the Board approve this order. It is required that this be approved prior to encumbering funds if the court approves it. Between Dewayne Rhodes and the Judge's we will get all the necessary documents to the Court in a form that they are happy with. Chairman Skinner stated, that Dewayne Rhodes would be here next week with a presentation to this Board. Seeing no reason why this will not pass the Board, we will be able to get this project started. Leroy Krohmer stated, that the project has been worth waiting for that we have saved the money and do not have to ask taxpayers for money.
