The regularly scheduled meeting of the Board of County Commissioners was called to order this 24th day of November, 2003, in the conference room of the County Office Building by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Dan Cary, Safety Director, stated that in December of last year the County applied for a Hazard Mitigation Grant under that program and received a notice from the State that the funds were available to interment a plan and in February of this year the County submitted a project application that was approved by the Board of County Commissioners to FEMA for the funds. The application has been approved and \$144,000.00 is available for the project, which is a 25% match. This is a countywide project not only involving Cleveland County, but Moore, Norman, Noble, Slaughterville, and Lexington. Mr. Cary is requesting that the Board sign the documentation indicating its approval so it can be sent back to the State by the 27th.

Mike McDanel, Assistant District Attorney, stated that the terms of this grant were approved with the application back in February so it is appropriate, it has been before the Board and the terms have previously been approved and it can be signed today.
