December 22, 2003

The regularly scheduled meeting of the Board of County Commissioners was called to order this 22nd day of December, 2003, in the conference room of the County Office Building by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of December 15, 2003, and there being no additions or corrections, Bill Graves moved that the minutes be approved. Leroy Krohmer seconded the motion.

Chairman Krohmer called for the awarding and/or rejecting of County Bid #Com-1210 – Courthouse/County Office Building Construction Project.

Tammy Howard, Purchasing Agent, stated that there was one vender with would like to withdraw and that this was discussed in the work session Friday. The vender is SGS and they have a legitimate reason and Ms. Howard is submitting a letter to withdraw.

Mike McDanel, Assistant District Attorney, stated that he and the Architects spoke about this last week. The letter was provided which he thinks to be appropriate and sets forth a lawful reason, as they made an error in their bidding and his recommendation to the Board entertain a motion to allow SGS to withdraw their bid.

Dorinda Harvey, County Clerk, asked if she understood in the work session meeting on Friday that the 4th floor of the Courthouse would eventually have to be vacated. Mr. Rhodes stated that the 3rd floor was the discussion; there are areas of the 4th floor, which is the attic floor that will have some work relative to air-conditioning equipment. The dialog that he has had with the Judges and with Mike McDanel, Assistant District Attorney, is there any conflict, because those are judicial records, the concern was could workman be around those files or would they need to be separated. He was told that they are public records except for adoption paper and they would have to be stored somewhere else. That is one of the items that need to be worked out with the Contractor in the sequence of phasing and he would anticipate some files might have to be moved but not all of that area would have to be. F. DeWayne Beggs, Sheriff, asked if a crane was going to be needed in the back or south parking lot. If so it may shut the Sheriff down because that is his access to the jail. Mr. Rhodes stated that there will need to be a crane on the premises and what has been discussed is that before we go into schedule sequence, location, storage, equipment and cranes the contract has to be awarded and get a contractor on board and have that preconstruction meeting and have that dialog. He will take that into consideration when that happens.

Chairman Krohmer asked if Mr. Rhodes had anything else from the other bidder. Mr. Rhodes stated that the seconded apparent bidder (low bidder) Nashert Construction, calls has been put in as was discussed in the work session asking for a current pre-qualification statement with references so those can be checked prior to next Monday's meeting and they have responded. There being no further business to come before the Board, Bill Graves moved that the meeting be adjourned. Leroy Krohmer seconded the motion. The vote was: Leroy Krohmer, yes; Bill Graves, yes.
