March 8, 2004

The regularly scheduled meeting of the Board of County Commissioners was called to order this 8th day of March, 2004, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Bill Graves. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Graves began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of March 1, 2004, and there being no additions or corrections, George Skinner moved that the minutes be approved. Leroy Krohmer seconded the motion.

Leroy Krohmer moved, seconded by George Skinner, to approve the Copier Maintenance Agreement between Cleveland County Commissioners and Sooner Copy Machines, L.L.C., for maintenance on Ricoh FT-6645 Copier at \$59.00 per month and \$.021 for over 3300 copies.

Chairman Graves called for discussion, consideration, and/or action to approve the Application for Rural Economic Action Plan (REAP) Grant from Wildfire Estates. George Skinner stated that this covers the roads that did not get covered in the grant for last year and moved to approve. Leroy Krohmer seconded the motion. The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes. Motion carried.

Chairman Graves called for discussion, consideration, and/or action to approve the Resolution Authorizing Cleveland County to Designate the Twenty-Five Mile per hour speed limit in Wildfire Estates.

George Skinner stated that this covers roads that were in the grant last year and the Board that governs the road district within Wildfire Estates recommended it.

George Skinner moved to approve. Leroy Krohmer seconded the motion.

The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes.

Motion carried.

Chairman Graves called for discussion, consideration, and/or action on the appointment of a committee to study the division of funding for road maintenance among the Commissioner Road Districts.

Leroy Krohmer stated that he would like to see a study on the funding and made a motion to approve.

Chairman Graves stated that the motion died for a lack of a second.

Marsha Blair asked that this item have more consideration she stated that it had not been made clear as to why it was decided to divided the money the way it was and to have a committee work on the division of funds so in the eyes of some it would be more reasonable for the number of road miles.

Richard Brindley stated that he is speaking for this he thinks it should be reconsidered and if anything he thinks District #3 should receive more funds since they have the majority of the roads.

Bobby Tarp stated that cities like to go in and annex places so they can get the tax money but they don't want to be responsible for their actions. He does not see why our tax money should be sent to Oklahoma City to take care of their roads they don't send any down here. Bill Hightower asked several questions and stated that he did not understand how the percentage could be justified when the District #1 has 3 miles and District #3 has 256 miles. Chairman Graves stated that he thinks that it is a little more fair with the people that are putting in a lot of the tax money that is going to the south, regardless of whether they are in Oklahoma City, Moore or Norman the money still comes in and goes into the fund and is divided and is sent from the tax commission to ODOT to the Commissioners to use on roads

that the Commissioners feel need to be repaired.

Leroy Krohmer explained how the State funded road money. Mr. Krohmer stated that he has 71% of the rural roads; Mr. Skinner has 28% and Mr. Graves has 1%. Mr. Krohmer spoke of the money that was already committed for projects.

Edna Manning stated that they are just asking for fairness.

Chairman Graves explained about inter-local agreements and that the county can assist in the areas that the cities are having problems. The cities pay for the materials and the county does the work.

Barry Tarp asked if it was the responsibility of the county to help the cities?

Chairman Graves stated that it was not directly the responsibility. The cities get a percentage but not like the county does.

More discussion took place.

Chairman Graves read the item again and stated that Mr. Krohmer moved to approve.

Chairman Graves stated that the motion died for lack of a second. Chairman Graves made a motion to strike the item. George Skinner seconded the motion.

The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, no.

Motion carried.

Chairman Graves called for discussion, consideration, and/or action to determine membership of road fund division committee and to make such appointments as appropriate, and directing a time frame for such study.

Leroy Krohmer moved to approve. Motion died for lack of a second.

Chairman Graves moved, seconded by George Skinner to strike the item.
