Upon the recommendation of the Purchasing Agent, Leroy Krohmer moved, seconded by Bill Graves, to accept the bids and award and/or reject at a later date.

Motion carried.

Chairman Graves called for discussion, consideration, and/or action to approve acceptance of Courthouse Renovation alternate number two (2) on the addition and renovation of the Cleveland County Courthouse and Office Building. Also, approval of setting up consultation for next week to review the items necessary for the Commissioners, Judges, District Attorney, and other effected parties to better understand what the acceptance of the security alternate number ten (10) and what it would entail.

Mike Kelly with Kaighn Associate Architects stated this is a change order that is proposed and recommended to accept. This is for the Courthouse only and it does not affect the completion time of the County Office Building it extends by 200 days the contract only for the courthouse renovation. It is also an acceptance of an alternate that was previously priced out by the Contractor. It does not affect the ability of the Board for other change orders that the Board is limited by 10%. The other alternate is number ten (10) and Kaighn and Associate had a security consultant help design the locking arrangement for the facility and if that item would be accepted the Board will have to enter into an agreement for other hardware that can be purchased outside of this contract. This will be an explanation by the security consultant of what this would entail if the Board accepts this alternate. Upon the recommendation of Mike McDanel, Assistant District Attorney, Leroy Krohmer

moved, seconded by Bill Graves, to approve.

Dan Cary, Safety Director, made a brief presentation on the traffic problems and gave the Board some options that he had looked into.

Chairman Graves suggested that Mr. Cary and the Fair Board have a discussion on what needs to be done and moved to table discussion, consideration, and/or action to approve the traffic flow pattern and traffic control considerations for East drive at Cleveland County Fairgrounds Facility. Leroy Krohmer seconded the motion.

Leroy Krohmer moved, seconded by Bill Graves, to approve the Resolution authorizing application for financial assistance from the Rural Economic Action Plan Fund. The vote was: Bill Graves, yes; Leon Barnard, yes; Leroy Krohmer, yes. Motion carried.

Bill Graves moved, seconded by Leroy Krohmer, to approve the authorization, final approval and final action with respect to approving and authorizing the Board of County Commissioners of Cleveland County, Oklahoma to sign off on, approve and confirm a Public Hearing as required by the Tax Equity fiscal Responsibility Act ("TEFRA") relating to the Cleveland County Development Authority (The "Authority") Single Family Revenue Refunding Bonds Draw Down Series 2002 (The "Bonds") and authorizing the Chairman to sign off on, approve and confirm the hearing based on certification related thereto and ratifying all actions of the Board of County Commissioners and the Authority on April 14 and 21, 2003 and December 22 and 23, 2003, with respect to the issuance and amendment of the Bonds giving final approval of the amendment of the Bonds and waiver of competitive bidding related thereto. This is a seven and one-half million dollar (\$7,500,000) project. The vote was: Bill Graves, yes; Leon Barnard, yes; Leroy Krohmer, yes. Motion carried.

Leroy Krohmer moved, seconded by Bill Graves, to approve the authorization, final approval and final action with respect to authorizing and approving the board of County Commissioners of Cleveland County, Oklahoma to sign off on, approve and confirm a public hearing as required by the Tax Equity and Fiscal Responsibility Act ("TEFRA"), relating to the Cleveland County Home Loan Authority (the "Authority") Single Family Mortgage Revenue Bonds, Series 2004-A, in one or more series of a total aggregate amount not to exceed \$15,000,000 on a tax-exempt basis (the "Bonds"), authorizing and giving final approval of the issuance by the Authority of the Bonds and waiver of competitive bidding with respect to their sale and execution of all documents and the taking of all actions as necessary in connection with the issuance of the Bonds and authorizing the Chairman to sign off on, approve and confirm the hearing based on certification related thereto and ratifying all actions of the Board of County Commissioners and the Authority, with respect to the issuance of the Bonds.

Leroy Krohmer moved, seconded by Bill Graves, to approve the Allocation of Alcoholic Beverage Tax in the Amount of \$17,706.61.

Chairman Graves called for discussion, consideration, and/or action to approve the use of a parcel of land between Cleveland County and Allen Contracting, Inc. for use of land located at the Cleveland County Fairgrounds, as an office, parking and storage yardsite, 150 feet deep bounded by the Fairgrounds property line to the north, bounded by Porter Ave. to the west and bounded by Porter Ave. driveway into the Fairgrounds to the South. Yardsite would be used to the 1st day of October, 2004.

Wayne McPherson with the Cleveland County Fair Board stated that they do rent the area out but there is a charge of \$400.00 per month.

Chairman Graves asked Mike McDanel, Assistant District Attorney, if this could be voted on since in the agenda item no rent was mentioned.

Mr. McDanel stated that he believes that the item is efficiently specific if the Board wished to accept the proposal of Allen Contracting with the \$400.00 a month rental from this time until Allen has vacated the site sometime after the 1st of October. He believes the item has been on file and available for the public to review and is sufficient to cover this action by the Board today.

Leroy Krohmer told Raul Huerta Jr., with Allen Contracting, that a new contract would have to be brought in with the amounts.

Upon the recommendation of Mike McDanel, Bill Graves moved, seconded by Leroy Krohmer to approve the proposal with an addendum, a counter offer to include \$400.00 in rent and if that is accepted by Allen Contracting, Inc and at such time it is accepted and signed off by them, then it can be effective and they can move on site.
