Leroy Krohmer moved, seconded by George Skinner, to accept the bids for County Bid #COM-1236 and award and/or reject at a later date.

The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes. Motion carried.

Chairman Graves called for the awarding and/or rejecting of County Bid #COM-1233 – The Purchase of one (1) or more, New Model, Crawler/Dozer for the District #1 County Commissioner and stated that he had some notes to put into the minutes of the meeting. Mr. Graves then read from his notes, "I requested funds from the County Road Machinery and Equipment Revolving Fund and I received approval for up to \$140,000.00 for a bulldozer 140 minimum horsepower. I received the State's Bids Specifications not ours for a bulldozer 140 horsepower minimum. Had to use those specifications but was allowed to add options or additional items required. If I do not award to low bid, then I must state in the minutes of the meeting why I did not and the District Attorney either in the minutes of the meeting or by letter indicate approval or disapproval - all this is to be forwarded with a copy of the summary sheet, vendors and their bids to the ODOT Field Division and the State Auditor's and Inspector's Office. The bid items I looked at, a used, a new was not available, John Deere 750C, a Komatsu D61 not equipped as bid, but it was a live piece of equipment, a Dressta TD12C was not available to view. I checked the actual D6N Caterpillar that would be delivered if bid was awarded. The decision comes down to which machine has the most requested specifications. The availability of delivery, the best warranty, the best predicted resale value of years to come. The Dressta TD12C at \$155,460.00 is the low bid. The A/C (air conditioner) is not factory or if it is, it will be mounted on the roof top. We've had that one for several years with a roof top mount and it has been a tremendous amount of maintenance. I would rather not have that again. The warranty on Dressta 12C has it is written on the bid is twelve month - fifteen hundred hours. The John Deere and Komatsu have long delivery dates of sixty days. The Caterpillar D6N has the standard six months unlimited hour full maintenance warranty, three year-five thousand hour extended power train warranty and a two-year two thousand hour preventive maintenance oil change with filters at no cost to the County. The elevated final drive was requested by me as an option it being located up and out of the mud and water and most cases will increase the life of that system and when maintenance is performed on that system the tracks do not have to be removed. I believe the Caterpillar D6N has the best warranty, can be delivered within ten days and if the County had to sell the machine in several years it would have a good resale value to return funds to the State Revolving Fund and the County. In the past some piece of equipment that were purchased on the Revolving Fund have been turned back to the Revolving Fund and they have had a hard time finding a new owner because of resale value. I believe that the Caterpillar especially in the bulldozer line, there are 76 counties, one of which would probably take it, if I couldn't afford to pay for it. I move to award the bid to Warren Cat at \$179,700.00. \$140,000.00 will come from the State Revolving Fund and \$39,700.00 from District I funds that accrue after one July, 2004." George Skinner seconded the motion.
