Mike McDanel, Assistant District Attorney, suggested and he was trying to recall whether the people had told him that there was some time constraint, but Dorinda Harvey, the County Clerk, has the Plat, and if it otherwise appears to be an appropriate Plat and he really thinks the only reason those things come before the Board under the new statute is to make record of the Board's intent regarding maintenance of the roads. Mr. McDanel is assuming that it is the Board's intent not to maintain the roads at this time although you reserve the right to do that at a future date. If the Plat is otherwise appropriate he would recommend that the Board go ahead and approve the Plat subject to the parties requesting the Plat to place the proper language and endorsement on it, certification for the Board and Ms. Harvey knows what that language is and when that's done have it signed before filing and approve it subject to that prior to filing, that is Mr. McDanel's recommendation otherwise the Board can table it or strike it.

Chairman Graves stated that the County is not accepting the roads or the responsibility for the maintenance.

Mr. McDanel stated that would be his recommendation and once that is certificated on the Plat then it is clear to the public or somebody purchasing lots in the addition, to the abstractor and in the abstract. Mr. McDanel thinks that part of the problem in the past has been that people have been misled and told that the County would be maintaining roads and this would place on the Plat the Board's Certificate that the Commissioners are not at this time going to maintain the roads.

Leroy Krohmer asked why this could not be tabled until it was certificated and moved, seconded by George Skinner, to table until the Certificate is attached to the Plat. The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes. Motion carried.
