The regularly scheduled meeting of the Board of County Commissioners was called to order this 6th day of July, 2004, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Bill Graves. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Graves began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the special meeting of July 1, 2004, and there being no additions or corrections, George Skinner moved that the minutes be approved. Leroy Krohmer seconded the motion. The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes. Motion carried.

Upon the request of Tammy Howard, Purchasing Agent, Bill Graves moved, seconded by Leroy Krohmer, to award County Bid #SHE-1235 – One-Year (1) Non-Encumbered Contract for the purchase of Deputy Sheriff Uniforms for the Sheriff's Office, the bid term will be from the bid award date through one-year (1) to Special Ops Uniforms Bid #2, due to the uniform color, which closely matches what they currently wear. The vote was: Bill Graves, yes; George Skinner, yes; Leroy Krohmer, yes. Motion carried.

George Skinner moved, seconded by Leroy Krohmer, to award County Bid #COM2-1237 – The Purchase of one (1) or more, New Model, Self-Propelled Chip Spreader for the District #2 County Commissioner to Midwestern Equipment Company Bid #2 for \$ 92, 917.00, which is the middle bid. The low bid has a clutch transmission, Bid #2 has a hydrostatic transmission and with the eastern part of the county being hilly this would better serve the county. The interest free grant is for \$90,000.00, which will leave District #2 paying \$2,917.00.

George Skinner explained that the road is shared with the City of Norman, the west half of the road is the City of Norman's and the east half is the County's. Norman did a traffic study and they are recommending 40mph.
