September 12, 2005

The regularly scheduled meeting of the Board of County Commissioners was called to order this 12th day of September, 2005, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman George Skinner. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Skinner began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of September 6, 2005, and there being no additions or corrections, Bill Graves moved that the minutes be approved. Leroy Krohmer seconded the motion.

Chairman Skinner called for discussion, consideration, and/or action on the Resolution Levying 911 Emergency Wireless Telephone Fee in the amount of \$.50 per month or as otherwise authorized by state law for each wireless connection and providing for an election on December 13, 2005, for approval of said fee.

Zach Taylor, with the 911 Association of Central Oklahoma Governments, stated he was here to discuss the scheduling of an election for December for the purposes of making the 911 service fee that presently applies to wirelines phones apply to wireless telephones and to discuss what has occurred since the enhanced 911 system was implemented in Norman and Cleveland County. Mr. Taylor presented a power point presentation and stated that at the present time when calls come in for 911 from the cities and towns you get that cities police department and the unincorporated areas of the county those calls are process by the

Cleveland County Sheriff's Office. When you dial 911 on a wireless telephones emergency people don't know where you are and the call generally goes to a central number typically in Oklahoma City. It takes about three times longer to process an emergency call. Most callers who call 911 from a wireless phone don't know where they are. Wireline customers using 911 the calls route to the right place. The 911 system has been funded by the wireline customer and now with so many people are switching to wireless phones there is a dramatic drop in revenue. Wireless phones continue to grow and in conjunction with that a lot of people are simply unplugging their landline telephones. Today fifty percent of calls come in on wireless telephones. To remedy this situation several entities have been working for 911 to be built for wireless and explained some of those. The total user fee for wireless telephones if approved in an election would be \$.50. The funds collected for the user of wireless phones goes to pay the wireless companies to cover the cost of administering the collection fee. About \$.02 goes to SBC to cover costs that are tariffed by the Oklahoma Corporation Commission related to services specifically for the improvement to the networks, systems, and data base programs with them. The fee also covers the fact that the wireline customer is disappearing. The wireless fee will go to cover the core cost that is there to support the network, equipment, data bases, training and all those things that are ongoing that otherwise would have been in financial ruin if that revenue was not replaced. The steps to proceed on this are to follow the state law approved by the Senate, House and signed by the Governor and that is to have countywide elections to approve the \$.50 fee and these funds may not be used for anything else and they must be audited each year. Mr. Taylor took questions from the audience.

George Skinner stated that it was nine-thirty and there is a Budget Board scheduled the Commissioner's meeting needs to be recessed, called the Budget Board to order and then this meeting will reconvene.
