## October 31, 2005

The regularly scheduled meeting of the Board of County Commissioners was called to order this 31<sup>st</sup> day of October, 2005, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman George Skinner. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Skinner began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of October 24, 2005, and there being no additions or corrections, Bill Graves moved that the minutes be approved. Leroy Krohmer seconded the motion.

The vote was: George Skinner, yes; Leroy Krohmer, yes; Bill Graves, yes. Motion carried.

Chairman Skinner called for Item "1" under new business, presentation of Safety Awards to Cleveland County Employees. The awards were given to employees with five (5) to twenty-five (25) years of service without an accident.

Dan Cary, Safety Director, presented a plaque to the Commissioner's from ACCO, recognizing Cleveland County as one of the best 2004-2005 loss ratio self-insurance group pool members.

Upon the request of Tammy Howard, Purchasing Agent, Leroy Krohmer moved, seconded by Bill Graves, to accept the bids and award and/or reject at a later date County Bid #HWY-1274 – One-Year (1) Non-Encumbered Contract for Bulk Oils, Lubricants & Antifreeze for the County Commissioners, the bid term will be from the bid award date through three (3) months.

Chairman Skinner called for discussion, consideration, and/or action on the change proposal in the amount of \$12,679.46 for the relocation of S. Wall of room W206 at the Cleveland County Office Building, Norman.

Bill Graves stated that this office was found to be a little small. It is on the second floor and it is the Purchasing Office. The office to the north side of this is the multipurpose meeting room, conference room, Budget Board Meeting, and it could also be used as a courtroom if necessary. The wall between Purchasing and the multipurpose room can not be moved because it houses sprinkler system, electrical and a lot of other things. The wall on the south side of the Purchasing Office, and Mr. Graves referred to this as a floating wall, because it really doesn't have hardly any support or sprinkler system involve with it. This will move the south wall approximately three feet. Mr. Graves stated that you really wouldn't want to change the positions by giving purchasing the multipurpose room because that is too much space and the present Purchasing Office is too small to house a table with ten or twelve chairs around it plus public chairs against each wall and moved to approve the item. Leroy Krohmer stated that he spoke to the County Clerk about this and she is going to lose space in her office where the mechanical room is now that wasn't there before and that three feet is going to cramp her as far as where she is going to put her books. Mr. Krohmer ask Dorinda Harvey, County Clerk, is that wasn't right and that she was going to have less space than she did before.

Mrs. Harvey replied yes and that she did think she would have less space.

George Skinner stated that all of the County Officer's looked at this situation. The room that was set for the Budget Board Room would be used twice a month for about five minutes each time and everyone has indicated that they would like to move the Purchasing Department and the Budget Board Room, instead of having to pay twelve and a half thousand dollars plus thirty-three percent and Mr. Krohmer thought that would be about another four thousand dollars.

Chairman Skinner stated that item "2" died for lack of a second.

Leroy Krohmer moved, seconded by George Skinner, to approve the FY05 Drug Asset Forfeiture Annual Report.

Amounts will vary each quarter as to usage at \$0.0100 per copy.
