## April 10, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 10<sup>th</sup> day of April, 2006, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

Upon the recommendation of Tammy Howard, Purchasing Agent, Bill Graves moved, seconded by George Skinner, to award County #COM-1284 – The Purchase and Installation of Window Blinds for the Cleveland County Office Building located at 201 S. Jones, Norman, Oklahoma, to the low bidder of Russell Interiors. Section #1, \$8,880.00, (paperwork show \$8,800.00 which is the correct amount); Alternate #1, \$658.00; and Alternate #4, \$2,527.00.

Ms. Howard stated the start date is May 1<sup>st</sup> and will be complete in ten (10) days.

Chairman Krohmer called for discussion, consideration, and/or Action on the Jail Report from Neil Vickers.

Mr. Vickers stated for the period of March 30, thru April 5, there was an average population of prisoners of 143. The largest population being 153 and the smallest 137. During the month of March, the average daily population held at the Cleveland County Detention Center was 147, the highest number was 162 and the lowest was 133. During this reporting period there were six prisoners transported to the Department of Corrections. Mr. Vickers was

present last week when Don Garrison of the Oklahoma Department of Health for a room measurement of the detention facility. The facility measured approximately the same square footage as was reported in measurements previously taken. Mr. Vickers, stated that Mr. Garrison said that there could be a maximum of 177 prisoners housed at the jail. On April 4, 2006, Mr. Vickers received an e-mail from Mr. Garrison stating that he was withdrawing his request for any reports from Mr. Vickers. During this reporting period Mr. Vickers met with most of the Judges and discussed the ideas to maintain or lessen the number of that were incarcerated in the jail. Several prisoners during this reporting period were released on P.R. Bonds or lowered bonds by the Judges after hearings were held. One prisoner was held on civil charges and was released after Mr. Vickers worked with the District Attorney Office and Judges. Mr. Vickers met with several people from the Oklahoma Court Services and provided them with names of several prisoners who might meet their criteria for release with electronic monitoring. Oklahoma Court Services are interviewing these prisoners and presenting their findings to the District Attorney's Office and the Judges. Mr. Vickers will continue to monitor the jail population and make appropriate recommendations as they come up.

George Skinner moved to accept the report. Bill Graves seconded the motion. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Bill Graves moved, seconded by George Skinner, to approve the increase of the contingency fund from \$125,000.00 to \$155,000.00 for the remodel and additions to the Cleveland County Courthouse Building Project.
