May 15, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 15th day of May, 2006, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of May 8, 2006, and there being no additions or corrections, Leroy Krohmer moved that the minutes be approved. George Skinner seconded the motion.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

George Skinner moved, seconded by Bill Graves, to table discussion, consideration, and/or action to approve the Claim, Certification and Affidavit for the Department's acceptance of Final Plans for Project No. CR-114D(170), CR-114D(171), CR-114D(172), and CR-114D(173) Cleveland County, District 2, in the amount of \$8,050.00. Surfacing of County Road – Beginning at EW127 at NS328 (192nd Road) 3.0 miles North & 3.0 miles East of Needmore, OK, Extending 4.1 miles North to State HWY 9, District No. 2, Cleveland County, Oklahoma (T8 & 9, R1E). (Received corrected documentation with correct legal Townships 8 & 9 Range 1East.)

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated for the period from May 4th thru May 10th there was an average of 176 prisoners in the Cleveland County Detention Center. The highest count was on May 7th there were 191 prisoners and the lowest was May 4th with 151. After contacting the Judges during this period and reviewing the jail list the Judges had hearing on 6 prisoners and ordered the 6 back to the Department of Corrections. Two prisoners were released and placed on electronic monitoring.

Mental Health Court is being organized and should be operating within the next two weeks. When in operations, at least 6 prisoners presently in custody should be released to enter this program.

Mr. Vickers has contacted the City of Norman concerning 4 prisoners that have been in jail for over a couple of weeks and they are going to review that this week and try to do some disposition on those prisoners and get them out of the jail.

Mr. Vickers was gone for a while and just now believes he is catching up and making some positive effect on the jail population. He will continue to monitor the number of incarcerations and make appropriate recommendations.

George Skinner moved, seconded by Bill Graves to accept the report.

Sec. 176(d), (b) the waiver of competitive bidding with respect to their sale as required by 60 O.S. Sec. 176(e), (c) the ratification and confirmation of any and all terms of the Authority's resolution related to such financing and any and all matters related thereto and the execution of all related instruments thereto.

Chairman Krohmer called for discussion, consideration, and/or action to approve the Contract and Title Sheet for Bridge Replacements on 96th Ave. between Slaughterville Road and EW137 in Cleveland County District #3. (6 Structures: 14N3200E1330009, 14N320E1350007, 14N3200E1360008, 14E1340N3190009, and 14E1360N3190008). George Skinner stated 6 structures were listed but only 5 numbers given and Mr. Krohmer replied that one was going to be an alternate.

Dorinda Harvey, County Clerk, stated that was all that was on the agenda item. Leroy Krohmer moved to approve the five (5) structures on the agenda as one might have been left off. George Skinner seconded the motion.
