July 3, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 3rd day of July, 2006, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Leroy Krohmer. Roll was called by Christine Brannon, Deputy County Clerk/Secretary and those present were:

Leroy Krohmer, Chairman Bill Graves, Vice-Chairman George Skinner, Member Christine Brannon, Secretary

Others present were: Sarita Scott, Tammy Howard, Neil Vickers, F. DeWayne Beggs, Daniel Clements, J. D. Oller, Randall Turk, Sylvia Martin, Susan Moffat, Jane Cannon, Jerry Davis, Mike McDanel, and Rusty Sullivan.

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of June 26, 2006, and there being no additions or corrections, George Skinner moved that the minutes be approved. Bill Graves seconded the motion.

The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action to Approve the Official Closure of a ³/₄ mile segment of 168th St., (1 ¹/₂ miles north of Highway 39) beginning at the half mile line of Section 34, proceeding north to the ¹/₄ mile line of Section 27, (where the road currently ends) Cleveland County, Oklahoma. (This is in Township Seven North, Range One East.) Chairman Krohmer asked Mike McDanel, Assistant District Attorney Civil Division, under Old Business item (1) and (2) discussion, consideration, and/or action to Approve the Official Closure of a one mile section of 192nd St., between York Road and Duffy Road, Cleveland County, Oklahoma. (This is in Township Seven North, Range One East.) if these items need to be tabled again. Mike McDanel recommended both items to be tabled because they have not been published by the Wildlife Department. Leroy Krohmer moved, seconded by Bill Graves to table items 1 and 2 under old business. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during the reporting period of June 22nd thru June 28th the Cleveland County Detention Center held an average of 177 inmates. The highest number during this reporting period was 199 on June 25th and the lowest of 157 on June 22nd. During the seven day reporting period, the inmate population exceeded the 177 maximum number mandated by the Oklahoma Department of Health, on June 25th with 199 and June 26th with 192.

During this period, 8 prisoners from the Department of Corrections for court hearings were seen and transported back to the Department of Correction custody. Additional 12 prisoners had court hearings and were transported to various jurisdictions for court appearances in those jurisdictions. The increase in population was due in part to the large number of prisoners brought to the jail by local law enforcements agencies over the weekend. Forty-two (42) were brought in on municipal crimes and another 44 were charged with state offenses. Of these numbers, 26 were for public intoxication and 7 for driving under the influence. Another reason for the increase is due to the jury trials during this period, which occupied the time judges and prosecutors and delayed their ability to conduct hearings for recently arrested inmates. In the jail population, 15 prisoners have been held since before January 1, 2006. Since June 1, 2006, 129 have been arrested and are currently being held. Mr. Vickers will continue to monitor the jail population and make recommendations when possible.

George Skinner moved, seconded by Bill Graves, to accept the report. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Chairman Krohmer called for discussion, Consideration, and/or action to approve the Renewal of Jail Service Agreement by and between the Board of County Commissioners of Cleveland County and the Pottawatomie County Public Safety Center Trust. First Quarter of FY2006-2007 in the amount of \$51,400.00. Contract is for twenty (20) inmates at \$28.00 per inmates times 365 days equals \$204,000.00.

Chairman Krohmer made the motion for the County Commissioners Trust to pay for the first quarter out of R2, \$51,400.00, seconded by Bill Graves, to approve.

Bill Graves moved, seconded by George Skinner, to approve the Resolution Designating County Depository Banks for FY2007.

George Skinner moved, seconded by Bill Graves, to approve the Resolution to reimburse the Officials or Department Heads for services of Public Employees or other purposes from various entities, per Title 62, O.S. § 335. Said Resolution to begin July 1, 2006, and continue on a year-to-year basis.

Bill Graves moved, seconded by George Skinner, to approve the Resolution for the Cleveland County Investment Policy – July 1, 2006.

George Skinner moved, seconded by Bill Graves, to approve the Renewal Service Agreement between the Cleveland County Clerk and Eastman Kodak for a Kodak Mini Processor in the annual amount of \$2,876.00 from July 1, 2006, thru June 30, 2007. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

Bill Graves moved, seconded by George Skinner, to approve the Copier Maintenance Agreement between the Cleveland County Sheriff's Office and Sooner Copy Machines for following Sharp Copiers: Model #AR-M350NXA-Serial #45019515; Model #AR-M350NXA-Serial #45019575; Model #AR-M450NXA-Serial #3504676X; Model #AR-M207-Serial #45005411X. Contract Effective July 1, 2006, thru June 30, 2007. The cost per copy is \$.009, which will be billed monthly. Agreement includes parts, drums, labor, and toner on all machines.
