August 14, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 14th day of August, 2006, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of August 7, 2006, and there being no additions or corrections, George Skinner moved that the minutes be approved. Bill Graves seconded the motion.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during the reporting period of August 3, thru August 9, the Cleveland County Detention Center had an average population of 173 prisoners. There were only 2 days which exceeded the 177 maximum number mandated by the Oklahoma Department of Health. During this week's period the Sheriff's Office transported 13 prisoners to other jurisdictions after hearings were held in the Cleveland County Court System. The District Judges held hearings for 6 prisoners who were held for court costs and fines only and released them on set conditions. One prisoner was placed on electronic monitoring during this time period. The Sheriff's Office will transport 6 to 8 prisoners sentenced to prison time to the Department of Corrections later this week. During the weekend period from August 4, until August 7, the Norman Police Department arrested 28 people-19 on city charges and 9 on state charges. The Moore Police Department arrested 21 people-13 on city charges and 8 on state charges. The Cleveland County Sheriff's Department was shown as the arresting agency for 17 prisoners. Other agencies arrested an additional 9 people during this weekend.

Of the 75 prisoners arrested this weekend, 22 remained in jail as of 7:00 a.m. Monday, August 7. Eleven of the 22 prisoners were held on municipal charges. Mr. Vickers will continue to monitor the jail population and make recommendations when possible. George Skinner moved, seconded by Bill Graves, to accept the report.
