September 5, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 5th day of September, 2006, in the conference room of the Cleveland County Fairgrounds, 605 E. Robinson, Norman, Oklahoma, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Upon the request of Ms. Howard, George Skinner moved, seconded by Mark Meyer, to award the bid to Copelin's Office Center, they being the only bidder.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Upon the request of Tammy Howard, George Skinner moved, seconded by Mark Meyer, to table the awarding and/or rejecting of County Bid # HWY-1300 – Non-Encumbered Contract for Bulk Oils, Lubricants & Antifreeze for the County Commissioners. The bid term will be from the bid award date through four (4) months.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Upon the request of Tammy Howard, George Skinner moved, seconded by Mark Meyer, to table the awarding and/or rejecting of County Bid # HWY-1302 – Non-Encumbered Contract for Road Oils, Emulsions, and Sealants for the County Commissioners. The bid term will be from the bid award date though four (4) months.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated during this 7-day reporting period the average population per day at the Cleveland County Detention Center was 176 prisoners with 2-days just over the maximum number set by the Oklahoma Department of Health. During this week's period the Sheriff Office transported 11 prisoners that had been convicted and sentenced to prison time to the Oklahoma Department of Corrections. Another 14 prisoners were transported to other jurisdictions after hearings were held in the Cleveland County Court System. One prisoner was released who was being held for court costs and fines only. No prisoners were placed on electronic monitoring during this reporting period and the total number on the program as of this report was 23. The Cleveland County Mental Health Court currently has 6 people enrolled in the program and anticipates an additional 2 to be added later this week if a treatment facility becomes available. The Cleveland County Detention Center held 7 prisoners convicted and sentenced to time with the Department of Corrections. These 7 are awaiting future trials or hearings, or are awaiting a mandatory 10-day waiting period before transport. On Monday morning, August 28, 2006, the Cleveland County Detention Center held 17 municipal prisoners and 160 prisoners charged with state crimes. Mr. Vickers will continue to monitor the jail population and make recommendations when possible. George Skinner moved, seconded by Mark Meyer, to accept the report. The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

George Skinner moved, seconded by Mark Meyer, to approve the Renewal Contract between the Cleveland County Assessor and Business Imaging Systems for Hardware and Software Maintenance in the amount of \$5,995.00 annually. Contract is from July 1, 2006, thru June 30, 2007.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

George Skinner moved, seconded by Mark Meyer, to table discussion, consideration, and/or action to approve the Maintenance Agreement between the Cleveland County Health Department and Service Experts for ten heating and cooling systems in the Moore office 224 South Chestnut, Moore, for three (3) years for a total payment of \$4,560.00 to be paid at a rate of \$760.00 per visit over three (3) years at two (2) maintenance visits per year. Contract also includes repairs at a discounted rate of 15% to 25% off the retail price.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Chairman Krohmer stated this item probably needed to be stricken from the agenda as the County cannot enter into contracts for more than a year at a time and George Skinner stated that would probably be the best thing to do and withdrew his motion to table. Mark Meyer withdrew his second.

George Skinner moved, seconded by Mark Meyer, to strike this item from the agenda. The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action to approve the Addendum to Telecommunications Services Agreement between the Cleveland County Treasurer/Cleveland County Clerk and Cox Oklahoma Telcom, L.L.C. d/b/a Cox Business Services for upgrade from two-3M/512K CBI to one 1.5M/1.5M connection. Total monthly charges will be \$339.95 with an initial service Charges for Addendum \$99.95. The County Treasurer and County Clerk will rotate paying this bill. Chairman Krohmer stated this item needed to read from two-3M/512K CBI to1Mb/10Mb connection.

George Skinner moved, seconded by Mark Meyer to approve with the change. The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.

Chairman Krohmer stated the next item also needed to be changed from 1.5M/1.5M connection to read 1Mb/10Mb connection and George Skinner moved, seconded by Mark Meyer, to approve with the change the Agreement between the Cleveland County Treasurer and the Cleveland County Clerk to share the expenses for one 1.5M/1.5M connection with Cox Business Services. The Treasurer will pay the even months and the Clerk will pay the odd months.

George Skinner moved, seconded by Mark Meyer, to approve the appointment of Sharon Stanley as Receiving Officer for all Sheriff's Accounts.

The vote was: Leroy Krohmer, yes; George Skinner, yes; Mark Meyer, yes. Motion carried.
