The regularly scheduled meeting of the Board of County Commissioners was called to order this 2nd day of October, 2006, in the Cleveland County Office Building by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of September 25, 2006, and there being no additions or corrections, George Skinner moved that the minutes be approved. Bill Graves seconded the motion.

Chairman Krohmer welcomed everyone to the newly remodeled facility and said how proud of the building he was and asked for comments from the other Commissioners. Bill Graves stated he thought this was the first time in 20 years that all of the Elected Officials had something new. Mr. Graves stated he was proud the facility and it was accomplished without having to increase taxes on the public because the Elected Officials have saved money for over 12 years to get the building renovated. Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated that during this 7 day reporting period the daily average at the Cleveland County Detention Center was 175 prisoners with one day, September 24, exceeding the maximum number set by the Oklahoma Department of Health with that day being 187 prisoners in the facility. During this week's period the Sheriff's Office transported 8 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. There were 4 prisoners transported to the Department of Corrections after convictions and sentences of prison time. The District Judges released three prisoners held for court costs and fines only after new conditions were set. At this time 24 prisoners are on the electronic monitoring program. The Mental Health Court presently has 12 people in this program with several more pending evaluation. Over the past weekend period, the city police departments arrested 20 people on municipal charges for public intoxication. These arrests

were the largest contributor to the rise to the 187 prisoners on September 24. By Monday, September 25, only 1 of those remained in the county jail. Mr. Vickers will continue to monitor the jail population and make recommendations when possible. Bill Graves moved, seconded by George Skinner, to accept the report. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes. Motion carried.

George Skinner moved, seconded by Bill Graves, to approve the receiving of the Franchise Renewal Notice Requesting Commencement of Proceedings Under Section 626 of the Cable Act for Cox Communications.

Bill Graves moved, seconded by George Skinner, to approve the Contract between the Cleveland County Health Department and Deborah K. Mastin to provide Direct Observed Therapy and related services to tuberculosis patients. The terms for payment are not to exceed \$8,050.00 and the contract will end on June 30, 2007. The vote was: Leroy Krohmer, yes; Bill Graves, yes; George Skinner, yes.
