October 16, 2006

The regularly scheduled meeting of the Board of County Commissioners was called to order this 16th day of October, 2006, in the conference room of the Cleveland County Office Building, by Chairman Leroy Krohmer. Roll was called by Dorinda Harvey, County Clerk/Secretary and those present were:

Leroy Krohmer, Chairman Bill Graves, Vice-Chairman Dorinda Harvey, Secretary

Member George Skinner was absent.

Others present were: Christine Brannon, F. DeWayne Beggs, Tammy Howard, Mark Vasicak, Wit Merrell, Brittany Atwood, Casie Carson, Neil Vickers, Terran Manning, Denise Ellison, Sylvia Martin, Andy Reiger, and Susan Moffat.

Chairman Krohmer began the meeting with the Pledge of Allegiance.

After the reading of the minutes of the regular meeting of October 10, 2006, and there being no additions or corrections Bill Graves moved that the minutes be approved. George Skinner seconded the motion.

The vote was: Leroy Krohmer, yes; Bill Graves, yes. Motion carried.

Chairman Krohmer called for discussion, consideration, and/or action on the Jail Report from Neil Vickers.

Mr. Vickers stated that during this reporting period the average population in the Cleveland County Detention Center was 195 prisoners with each day's report exceeding the maximum number set by the Oklahoma Department of Health. During this period the Sheriff's Office transferred 3 prisoners to other jurisdictions after hearings were conducted in the Cleveland County Court System. No prisoners were transported to the Department of Corrections to serve prison time. Nineteen people are presently on pre-trial electronic monitoring. Two prisoners who were held for only court costs and fines had hearings and were released on the Judge's conditions. This past week's numbers are the highest recorded since Mr. Vickers accepted this position on March 1, 2006. These higher numbers appear to be due to many factors, which slowed the court process. None of the local law enforcement agencies appear to have increased significantly their number of arrest. The biggest factors in the recent temporary population increase are probably due to the move of the County Officials to the new office building, which postponed and slowed court proceedings for many defendants in custody, causing delays and rescheduling of jury trials. In addition, one District Judge has just returned from a two-week leave and he (Mr. Vickers) was gone for a big portion of last week. These factors and the 3-day holiday appear to have caused what he believes to be a temporary spike in the jail population. Over this past weekend the local city police officers arrested 21 people on municipal charges. Only 5 of these 21 prisoners remained in jail by

October 10th. There were an additional 26 people arrested on state charges during the same weekend with 13 of those 26 remaining in jail on October 10. Mr. Vickers will continue to monitor the jail population and make recommendations when possible.

Bill Graves moved, seconded by Leroy Krohmer, to accept the report.

Bill Graves moved, seconded by Leroy Krohmer, to approve the Contract for Services between the Cleveland County Board of County Commissioners and the Women's Resource Center to assist in providing temporary shelter and support to women and children who by reason of misfortune need such services. Contract period is from October 1, 2006, thru June 30, 2007, in the amount of \$16,874.99.

Agreement is from August 23, 2006, thru August 23, 2007.
